- Applicants are requested not to communicate about the project application process with members of the Region 3 Council during the application process.
- All applicants are required to utilize and complete the Application Packet shown on the website of the Southside Planning District Commission www.southsidepdc.org
- Applicants submitting projects that do not meet minimum qualifying criteria will be notified by Region 3 staff within one week of submission.
- Applications are considered confidential until such time as the Region 3 Council takes action on December 20
- Review of applications will be conducted in Executive Session at both the Review Team and Regional Council level.
- Qualified applicants will be invited to meet with the Region 3 Review Team on December 6; no presentations will be made to the full Region 3 Council.
- Region 3 Council will finalize its decisions based on the criteria noted in the Application Packet.
- All applicants will receive feedback after the Region 3 Council acts on December 20.
- Applications approved by the Region 3 Council will be submitted to the State Board for final action at its next meeting.
