The policy also provides for Commissioners to be able to attend and participate by electronic means in regular or special meetings of the Commission in accordance with this policy and state law. UPON MOTION BY JOHN ZUBROD, SECONDED BY JOSEPH CHANDLER, THE SPDC ELECTRONIC MEETINGS POLICY WAS ADOPTED UNANIMOUSLY AS PRESENTED.

GUEST SPEAKER

Executive Director Gosney noted that Dexter Gilliam, Mayor of the Town of Halifax, was instrumental in making the arrangements for this evening's guest speaker. Mr. Gilliam is the current President, CEO and Chairman of The Bank of Charlotte County. He also serves as the Chair of the Community Depository Institutions Advisory Council for the 5th Federal Reserve District. Ms. Gosney asked Mr. Gilliam to introduce our guest speaker, Renee Haltom, VP & Regional Executive, Federal Reserve Bank – Richmond District.

Ms. Haltom's work with the Federal Reserve Bank involves engaging business, banking, and community leaders on local economic conditions to inform the monetary policymaking process, as well as sharing information about the Federal Reserve System. Ms. Haltom is based at the Richmond office and has responsibility for public outreach and engagement in Virginia, as well as for the Community Depository Institutions Advisory Council. She has a bachelor's degree in economics from Michigan State University and a master's degree in economics from the University of San Francisco.

Ms. Haltom's presentation was entitled "Improving Employment in Rural Communities." Her presentation centered on the definition of rural communities, the reason economic outcomes tend to be worse in these rural communities and potential solutions to reverse the affects. She examined how rural communities are much more likely to be shrinking and how employment tends to be lower than in neighboring urban communities. Skill barriers such as education and training and non-skill barriers such as childcare, healthcare, infrastructure, and incentives are the problem. Solutions to these hindrances tend to be harder in rural communities; however, rural communities do have great assets. Local assets can include hospitals, community colleges, four-year colleges and universities and Community Development Financial Institutions (CDFIs). Their roles can be vital to rural communities. Communities strengthen themselves with regional collaboration, playing to their strengths and weaknesses, creating a sense of place, telling a good story,

developing strong leadership, and taking a long-term view. Ms. Haltom explained a concept called "Virtuous Loops." Virtuous loops are "economic activity which creates more economic activity which further promotes the first occurrence and so on resulting in a continuous process of improvement." Virtuous loops are needed in rural communities to create success in higher employment and then to duplicate it. The Richmond Fed is actively pursuing ways to support rural communities as well by Community Partnership, Applied Research, Events and Communications and Sensing and Engagement.

CLOSING COMMENTS AND ADJOURNMENT

In closing, Vice Chair Leonard thanked Ms. Haltom for her interesting and informative presentation and thanked Dexter Gilliam for enlisting her as our guest speaker. Additionally, he thanked Brunswick County for hosting our Annual Dinner Meeting this year.

The meeting adjourned at 8:15 p.m.

SPDC Electronic Meetings Policy

All-Virtual Public Commission Meetings

The Southside Planning District Commission may conduct all-virtual public meetings in accordance with this policy and state law. For purposes of this policy, "electronic means" shall be defined as attendance via telephone, video and/or audio conferencing, or another electronic device.

The Commission may hold all-virtual meetings and conduct business by electronic means in a regular or special Commission meeting pursuant to the *Code of Virginia 2.2-3708.3* in accordance with the following:

- 1. An indication of whether the meeting will be an in-person or all-virtual public meeting is included in the required meeting notice along with a statement notifying the public that the method by which a public body chooses to meet shall not be changed unless the public body provides a new meeting notice in accordance with the provisions of § 2.2- 3707;
- 2. Public access to the all-virtual public meeting is provided via electronic communication means;
- 3. The electronic communication means used allows the public to hear all members of the public body participating in the all-virtual public meeting and, when audio-visual technology is available, to see the members of the public body as well;
- 4. A phone number or other live contact information is provided to alert the public body if the audio or video transmission of the meeting provided by the public body fails, the public body monitors such designated means of communication during the meeting, and the public body takes a recess until public access is restored if the transmission fails for the public;
- 5. A copy of the proposed agenda and all agenda packets and, unless exempt, all materials furnished to members of a public body for a meeting is made available to the public in electronic format simultaneously with when such materials are provided to members of the public body;
- 6. The public is afforded the opportunity to comment through electronic means, including by way of written comments, at those public meetings when public comment is customarily received;
- 7. No more than two members of the public body are together in any one remote location unless that remote location is open to the public to physically access it;
- 8. If a closed session is held during an all-virtual public meeting, transmission of the meeting to the public resumes before the public body votes to certify the closed meeting;

- 9. The public body does not convene an all-virtual public meeting (i) more than two times per calendar year or 25 percent of the meetings held per calendar year rounded up to the next whole number, whichever is greater, or (ii) consecutively with another all-virtual public meeting; and
- 10. Minutes of all-virtual public meetings held by electronic communication means are taken as required by \$ \$ 2.2-3707 and include the fact that the meeting was held by electronic communication means and the type of electronic communication means by which the meeting was held. If a member's participation from a remote location pursuant to this subsection is disapproved because such participation would violate this policy, such disapproval shall be recorded in the minutes with specificity.

A Commissioner's failure to comply with this policy may result in the Commission's refusal to allow the Commissioner to participate by electronic means in Commission meetings.

Provisions of this policy will also apply to any committee, subcommittee or other entity designated by the Commission to perform delegated functions of the organization.

Remote Participation By Individual Commissioners

Commissioners of the Southside Planning District Commission may attend and participate by electronic means in regular or special meetings of the Commission in accordance with this policy and state law. For purposes of this policy, "electronic means" shall be defined as attendance via telephone, video and/or audio conferencing, or another electronic device.

Commissioners may attend and participate by electronic means in a regular or special Commission meeting pursuant to the *Code of Virginia 2.2-3708.3* for any of the following reasons preventing that Commissioner from physically attending the meeting:

- The Commissioner has a temporary or permanent disability or other medical condition that prevents the Commissioner's physical attendance;
- A medical condition of a member of the Commissioner's family requires the Commissioner to provide care that prevents the Commissioner's physical attendance;
- The Commissioner's principal residence is more than 60 miles from the meeting location identified in the required notice for such meeting; or
- The Commissioner is unable to attend the meeting due to a personal matter and identifies with specificity the nature of the personal matter. However, the Commissioner may not use remote participation due to personal matters more than two meetings per calendar year or 25 percent of the meetings held per calendar year rounded up to the next whole number, whichever is greater.

A Commissioner who seeks to attend and participate by electronic means in a Commission meeting shall notify the Executive Director and/or Chair. If the request is approved by the Executive Director and/or Chair, a Commissioner who attends and participates by electronic means shall identify the location from which he or she is participating, as well as those present at that location. If the Commission convenes in Executive Session, the Commissioner attending and participating by electronic means shall ensure confidentiality during that portion of the meeting.

A Commissioner who attends and participates by electronic means in a Commission meeting shall have access to any materials that are presented and available to Commissioners who are physically present at the meeting.

A Commissioner's failure to comply with this policy may result in the Commission's refusal to allow the Commissioner to participate by electronic means in Commission meetings.

Provisions of this policy will also apply to any committee, subcommittee or other entity designated by the Commission to perform delegated functions of the organization.
